#### **ACMG Salary Survey Statistics Released**

The Final Report of the 2007 ACMG Salary Survey is now available in the Members Only section of the ACMG website. This report presents findings from the first national survey to specifically collect data about the compensation of MD and PhD Medical Geneticists in the United States. The Final Report supersedes the Preliminary Report released in November 2007. It includes 25<sup>th</sup> and 75<sup>th</sup> percentile salaries, salary comparisons based on administrative positions, and salary comparisons based on the number of laboratory directors at a site and by director title (e.g., Senior Director, Co-Director, Associate Director, etc.). The American College of Medical Genetics will continue to conduct salary surveys of the profession on a periodic basis, with findings available as a "Members' Only" benefit.
