Something which is a big issue at the moment is the striking off by the GDC of registrants for minor CPD infractions – just failing to log an hour or two of the required ten hours every two subsequent years is leading to erasure from the Register... If you aren't registered, you can't work! BADN

has had several meetings with the GDC on this issue and another is scheduled; we are also backing the 'Saving Grace' campaign, which is a petition calling on the GDC to be more sympathetic and understanding of real life problems which can lead to registrants missing an hour or two of CPD – and also calling for those who do to be allowed to make up the missing hours instead of being struck off. One of the facets of this issue is the fact that many registrants are not fully aware of their CPD requirements, or of the so-called '10/2 Rule'; BADN members can access an explanatory article on CPD in the *British Dental Nurses' Journal* library. They can also download a CPD Activity Log and Personal Development Planner to help keep track of CPD; and the Journal includes up to two hours of CPD per issue.

## Annual Robin Davies DCP Research Awards take place in London

The annual Robin Davies DCP Research Awards luncheon was held in November to celebrate the 2023 award winners. The celebration was held at Linden House, London and was attended by leaders of dentistry from across the UK. The Oral and Dental Research Trust (ODRT) partner with Colgate annually to offer a £5,000 research grant to award winners, exclusively dental care professionals (DCPs).

The keynote speaker for this event was interim Chief Dental Officer for England, Jason Wong, who said 'The Robin Davies DCP Research Awards, I believe, are still unique in providing DCPs the opportunity to carry out research. In many cases, this is the first introduction to research methodology for those who have never previously been involved in research.'

Sir Nairn Wilson, ODRT Trustee, invited the 2023 awardees to share their proposals with the audience.

Dental nurse Helen Bullingham is investigating if oral healthcare training can enhance parent confidence in their ability to influence their child's oral health, increasing toothbrushing episodes and reducing challenging toothbrushing behaviour of autistic children.

Mark Thurston, dental nurse and student dental hygienist and therapist, aims to evaluate the effectiveness of an integrated care plan with accessible elements using a nursing model in enhancing communication and referrals between healthcare and dental teams for people who live in residential services.

Dental nurse Nikki Legg is working towards gaining an understanding of the difficulties faced by children and staff in Special Educational Needs (SEN) Schools in relation to oral hygiene and diet.

Dental hygienist Tracey Kinsella will be focused on determining the level of

confidence in Critical Care Nurses and Health Care Support Workers providing oral care to individuals who are intubated/mechanically ventilated.
