## DENTIST VOLUNTEERS REQUIRED FOR BURMA

Dentist Shaila Patel is looking for volunteer dentists to join her when she travels to the Thai/Burma border on 5 November 2010 to train local men and women in basic dental skills.

Shaila will be part of a small medical team from the UK which will also includes doctors, nurses and midwives and which is organised by charity HOPE 4 the World.

Burma is one of the poorest countries in the world after over 50 years of civil war, despite plentiful natural resources. Thousands have been killed by the military dictatorship and millions are displaced. There is continual environmental destruction, an HIV/ AIDS epidemic, the ongoing laying of landmines, human trafficking and religious persecution.

The internally displaced people (IDPs) lack security, food, education for their children and have limited access to the most basic of medical care.

HOPE 4 the World buys all of the equipment for the trips but the travel costs are self-funded by volunteers. The charity also builds schools in Burma, provides maintenance grants and delivers teacher training.

#### FELLOWSHIP FOR CRANIOFACIAL RESEARCHER

Researcher and Lecturer in Orthodontics, Rishma Shah, has been awarded a two-year Fellowship by the Faculty of Dental Surgery of the Royal College of Surgeons of England.

The prestigious award will support Miss Shah's ongoing research, begun during her postgraduate studies, into the creation of *in vitro* craniofacial skeletal muscle tissue for use in the development of novel therapies to treat craniofacial deformities such as cleft lip and palate, with the ultimate aim of providing tissue for use in facial implants to replace muscle tissue deficiencies.

It is anticipated that the Fellowship grant will allow Miss Shah to find a suitable way of integrating biologically engineered craniofacial muscle with tendon and bone attachments, which would provide a valuable contribution to the field.



## **CONSULTATION ON PANEL NUMBERS OPENS**

The General Dental Council (GDC) is asking for views from registrants and the public on a change to the regulator's rules allowing it to employ more Fitness to Practise (FtP) panel members.

FtP panel members sit on public hearings, which are the final stages of investigations into dental professionals. Panel members will be asked to make difficult decisions about whether the GDC should step in to set out how and if a dental professional should carry on working.

In the last year the FtP panel's caseload has risen by 40% and the GDC is determined to tackle it head on. A consultation must take place first as an increase in panel numbers requires a change to the Council's Constitution of Committees Rules 2009.
