## New legislation for unlicensed medicine

The Medicines and Healthcare products Regulatory Agency (MHRA), has introduced legislation designed to minimise the risk of transmissible spongiform encephalopathies (TSE). The legislation works by prohibiting the supply of certain unlicensed medicines unless they have been manufactured in accordance with the 'Notes for Guidance on Minimising the Risk of Transmitting Animal Spongiform Encephalopathy Agents via Medicinal Products' as published and updated by the European Commission.

The regulation of certain unlicensed medicines for human use is needed in order to minimise the risk of the transmission of transmissible spongiform encephalopathies (TSE) via those products.

The legislation, 'The Unlicensed Medicinal Products for Human Use (Transmissible Spongiform Encephalopathies) (Safety) Regulations (S.I. 2003/1680)', came into force on 30 July 2003. Dentists who specially prepare medicines in the course of their business are not exempt and are required to comply with the Regulations. The Regulations, which also contain a procedure to determine compliance and a requirement for a designated record-keeper to keep evidence of compliance, affect all manufacturers and importers/exporters of certain unlicensed medicinal products.

## Dentaid in Great North Run



A large Dentaid tooth was just one of the 47,000 participants in this year's Great North Run, the world's largest half-marathon. Chief Executive Luke Wordley and Dentaid supporter Jon Beisly carried the massive molar the full 13.1 miles from Gateshead to South Shields. Sharing the load, the pair took just over two and a half hours to run their way to the finish. The first Dentaid runner to complete the run was Elizabeth Athey, a dentist from Lymm in Cheshire, completing the course in 1 hour 37 minutes. Dentaid turned out their largest team to date; 23 runners from all over the country trained hard for the event, and raised an estimated £5000 for oral health in the developing world. ## GDC restoration and registration

The GDC expects to answer over 5,000 telephone enquiries about the Annual Retention Fee for 2004 and process 6,000 changes to register details during the beginning of this year. The team will process over 35,000 payments (generating over £12 million income). The fee must be paid on or before 9 February 2004.

According to the GDC, the new registration and restoration application forms which came into use on 1 January 2004 introduce an improved and standardised approach to registration, and a more robust system of medical checks and character testimonies. Work is continuing on improving the content of the registration pages on the GDC website. It is hoped that a more extensive and informative section will be added to the website early in the new year.

From January 2004 onwards, applicants for restoration to the register will be required to show evidence of CPD compliance in order to restore to the register. A consolidated set of CPD rules which show the requirements which dentists and the registrar must meet under the CPD scheme came into effect on 1 January 2004. A further set of rules, governing the procedure for the CPD Committee also came into effect on 1 January 2004. Both sets of rules are on the GDC website.

The Council has been continuing its work to develop a system for revalidating members of the dental team and a Revalidation Consultation Forum has been established. Revalidation will require all registrants to demonstrate on a periodic basis that they remain fit for continued registration.

## Dental hospital celebrates Golden Jubilee

The Charles Clifford Dental Hospital (CCDH) in Sheffield recently celebrated its golden jubilee following 50 years of providing dental services to the people of Sheffield.

Officially opened in 1953 by Her Grace The Duchess of Gloucester, it was founded by Colonel Sir Charles Clifford, Commander of the Sheffield Territorial Artillery and the 126 Brigade Army field Artillery.

In 1935, on learning of the need for new accommodation for the Sheffield Dental Hospital and School, he donated land and the sum of £7,800 for equipment. Sir

Charles died in 1936 leaving the University £78,000 before the plans for the hospital were finalised. Delayed by the Second World War the foundation stone was finally laid on the 12th of September 1951 by the Minister of Health Hilary A Marquand MADSc. MP. Alumni and former staff toured the hospital, a balloon race raised funds for the Meningitis Trust and staff and guests attended a Service of Thanksgiving.
