#### Name change

On the 1 April 2005 the Defence Dental Agency was renamed the Defence Dental Services, under leadership of its new Director, Brigadier Chris James. The disestablishment of the Defence Dental Agency as a Defence Agency was announced at the beginning of this year by the Under Secretary of State for Defence.

There will be no staff cutbacks as a result of the removal of Agency status. The Defence Dental Services will continue as a tri-Service military organisation, providing dental services to all members of the UK Armed Forces and those entitled civilians working for the military residing overseas, and will become more fully integrated within a coherent military healthcare delivery system.

Brigadier James and his staff will continue to operate from the Defence Dental Services headquarters at RAF Halton in Buckinghamshire.

#### New first

Dr Michael R. Norton recently became the first Fellow from within the United Kingdom to be inducted as the 75th Fellow of the Academy of Osseointegration in Orlando, Florida USA at its annual congress.

The Academy has over 5,000 members and fellowship is conferred on those who can demonstrate a significant contribution to the field of osseointegration and to the Academy itself. Dr Norton represents only the tenth such Fellow from outside the North American continent.

In the study, 'An appraisal of options of the training and education of Professionals Complementary to Dentistry' by J. T. Newton, K. Jones, P. D. Newton and D. E. Gibbons to be published in the next issue of the *BDJ*, a review of training and education programmes for PCDs throughout the world was undertaken and the programmes of training were said to vary along four dimensions: the role which the learner trains for; the nature of the qualifications required for entry to the training



pathway, the method of training and the location of training.

An educational model of the training and education of PCDs is proposed based upon these four dimensions, which seeks to maximise the benefits of the elements whilst minimising the disadvantages.

## Increase in exam fees

The General Dental Council has agreed to seek an increase in the fees charged to candidates sitting the International Qualifying Examination (IQE), to help meet the growing demand for places from overseas dentists wanting to work in the UK.

The IQE is funded by the fees candidates pay to sit the exam. To be able to run a new, larger programme of sittings, the GDC has agreed to increase the fees for Parts A and C of the IQE from £550 and £750 to £600 and £950 respectively, and to leave the Part B fee (£650) unaffected. The fee increases are expected to be implemented for all IQE examinations taking place after June 2005, subject to approval by the Privy Council.

In 2004, the GDC increased the capacity of the IQE by over 120% compared to the capacity for 2003, thanks to a special subsidy from the Department of Health (England) and the support of UK dental schools, which hold the exam. As a result, candidates' waiting times were reduced significantly and 199 dentists became eligible to apply for GDC registration over the year.

The GDC is keen to ensure that IQE candidates continue to have an early opportunity to sit the exam and has negotiated a flexible programme of IQE sittings with dental schools, with enough capacity to meet the expected demand for places over the next two years. It claims this should enable dentists to go through the examination process more swiftly than in the past.

GDC President, Hew Mathewson said: "The IQE is self-funding. The GDC covers

the costs of running the examination through candidates' fees, rather than subsidising it through the annual fees paid by GDC registrants. The Department of Health has offered a fixed sum to help fund the new, extended, flexible programme of IQE sittings, but an immediate increase to candidates' fees is needed to ensure the GDC covers its costs and those incurred by the dental schools holding the exam."

The IQE is the GDC's examination for dentists from overseas who wish to practise in the UK but whose primary dental qualifications are not recognised for full registration with the GDC. The examination tests the dentist's skills and knowledge and, after passing all three parts, successful candidates can apply for registration with the GDC.



# GDC spotlight on implant dentistry

The GDC's Implant Dentistry Group was set up last January to review standards and training in implant dentistry and to make recommendations to the GDC's Education Committee on how best to protect the public.

In October the Group reported to the Education Committee on its findings and identified that implant dentistry is a new and fast growing aspect of dentistry, an invasive procedure which, in circumstances where a dentist has not been adequately trained, poses a risk to patients and an area in which there is a lack of guidance for dentists.

The Education Committee endorsed the concerns identified in the Group's report. According to the GDC, though it requires dentists to practise only within their competence, the report suggests that some dentists are practising implantology without adequate training. It adds that whilst it is not responsible for the setting of detailed clinical standards in particular areas of dentistry, it is clear that action is needed to protect patients. The GDC will be setting up a meeting with the various professional groups to facilitate the setting and publication of core dental implantology guidelines, and to establish a longer-term mechanism for updating this guidance.

# Winning presentation

Two dental students from Dundee Dental School won first prize for their presentation entitled "Quantitative <sup>1</sup>H Magnetic Resonance Micro-imaging of Teeth" at the 2005 BDA / Dentsply Student Clinician Programme.

Eilidh Morgan and Nadia McMinn were among students from fourteen dental schools in the UK and Ireland who participated in the event. Their prize is an all expenses paid trip as guests of Dentsply International, to the American Dental Association's Annual Conference to be held in Philadelphia in October.

Each of the participants was honoured at the annual dinner, this year held at London's Savoy Hotel.
