## Oral cancer screening investigated

Opportunistic screening for oral cancer in general dental practice in the UK is unlikely to be an effective preventive strategy, according to a recent paper in the *Journal of Medical Screening* (Netuveli G, Sheiham A, Watt R G. *J Medical Screening* 2005; **13**: 47-50).

The researchers, from Imperial College and University College, London studied data from individuals collected in two large national surveys to identify the relationship between dental attendance and recognised oral cancer risk factors. The factors included were males of age over 40 years, alcohol intake greater than 28 units per week, cigarette consumption above 20 per day, and fruit and vegetable consumption of less than five times per day; which were combined to create a risk score.

Overall, the probability of regular dental attendance was low in all groups who demonstrated a higher risk of oral cancer, indicating that the yield from opportunistic screening for the condition during dental check-ups is likely to be low. Noting that risk factors tend to cluster, the authors suggest that a probable explanation of their findings is that drinking, smoking and a poor diet generally go together and that such individuals are the least likely to take preventive action of any sort.

## FGDP(UK) and FDS move to establish joint college



The Faculty of General Dental Practice (UK) (FGDP(UK)) and the Faculty of Dental Surgery (FDS) have announced their intention to move towards the establishment of a joint college. Formation of the college is supported by the Faculties' parent body, the Royal College of Surgeons of England, under whose auspices the new organisation will be created.

Dean of the FGDP(UK), Mike Mulcahy, said that a single, recognised academic home for the whole profession was overdue. 'Our combined membership of primary care practitioners, specialists and dental care professionals is in excess of 6,000, which would represent a very strong voice among the institutions of dentistry,' he said. 'The concept is that each Faculty will retain its own identity under an umbrella organisation, but prior to that, proposals for the joint college will be subject to consultation with the membership of each Faculty.'

The Faculties have been collaborating for some time to merge their two membership examinations – the MFGDP(UK) and the MFDS – into a single, more flexible exam for launch in late 2007. They have also been increasing the number of joint educational programmes and activities they offer. Professor Farida Fortune, Chair of the FDS Examinations Committee, said: 'The aim of the new examination will be to assess competencies and it can be taken by any dentist at the end of two years of General Professional Training or at any point in their career thereafter. In this way, mobility between the primary and secondary sectors of dentistry will be enhanced.'

A formal announcement will be made in the FGDP(UK)'s forthcoming April newsletter to members.

## First toothpaste available on DPF

## Local anaesthetic shortage

Dentists are finding it increasingly difficult to obtain supplies of dental local anaesthetics (LAs) due to the shortage that has arisen since Dentsply ceased production of some of their product range. The BDA and the Department of Health are aware of the situation and are trying to resolve the issue as quickly as possible.

Members of the BDA's Dental Advisory Group to the British National Formulary discussed the current shortage of LAs with the Department of Health (DH) during a meeting on March 1st. The DH is in regular contact with Septodont, an alternative LA supplier, who has issued a statement saying it is confident it will be able to supply the anaesthetic needed by the market as and when required. Together they are attempting to resolve the problems as quickly as possible and are looking into the possibility of obtaining supplies from the continent. In addition, the DH is considering conducting a census to establish an accurate UK-wide picture of the situation and identify whether particular regions are having more difficulty than others in obtaining LA supplies. It was noted in the meeting that bulk buying by dentists would not help attempts to resolve current supply problems.

The DH has agreed to keep the BDA updated about any action to rectify the shortage and the BDA is also in regular contact with both Dentsply and Septodont. The BDA will keep members updated of any changes to the current situation through the BDA website ([www.bda.org](http://www.bda.org)) and will also inform members of the outcome of any action that has been taken. The full statement issued by Septodont on 8 March is also available to read on the site.

The BDA and Septodont would like to encourage dentists to order stocks at a 'normal' rate wherever possible and not to be tempted to bulk buy, as this could put more pressure on supplies.

## NI dentists call for more preventative approach

Dentists in Northern Ireland want more time to help their patients have healthier teeth and avoid dental disease, according to the BDA's submission to the Primary Dental Care Strategy Consultation. More than two-thirds of high street dentists in Northern Ireland believe that they need more time with individual patients so they can take a more preventative approach to care.

The BDA's response to the consultation was informed by a survey of dentists in Northern Ireland. Almost 90% of practitioners agreed that dental care provided by the NHS in Northern Ireland needed to be modernised to improve patient care. Claudette Christie, the BDA's Director for Northern Ireland, said: 'Dentists need to be able to take a more preventative approach to care and this would be a real step forward in addressing Northern Ireland's disappointing oral health record.'

The BDA's response stresses that reform must be properly managed and that the Health Service must use the considerable skills of dentists and their staff if the dental health of the people of Northern Ireland is to be improved. 'This is a time of opportunity for dentistry in Northern Ireland,' said Claudette Christie, 'but it's crucial that any reforms are properly funded and meet the needs of both patients and dentists.'

## BDA defers implementation group decision

The BDA has deferred a decision on whether or not to join the Government's implementation group set up to monitor the impact of the changes to NHS dentistry. Lester Ellman, Chair of the BDA's General Dental Practice Committee, has written to Health Minister Rosie Winterton saying he needs more information about the group's remit and what membership will involve.

In a letter to the Minister, Dr Ellman pointed out that the BDA had already called for a review of the new contract and underlined that it was vital for both patients and dentists that the impact of the changes is properly monitored and understood. He continued 'We need to be convinced that the implementation group will provide genuine opportunities to tackle the problems that we believe the new arrangements will cause for patients and dentists.'

Rosie Winterton announced the setting up of the implementation group on 7 March, in response to concerns about the new dental contracts. Dr Ellman also stated in the letter, 'We need to be assured that our membership of this group will not be presented as an endorsement of the Government's reform programme. The BDA has grave concerns about the new contract itself and the way it is being introduced.'

## Raman Bedi joins Howden Dental advisory board

Former Chief Dental Officer Professor Raman Bedi has been appointed to the advisory board of Howden Dental, a division of Howden Medical Insurance Services.
