## AAE issues position statement on bisphosphonates

The American Association of Endodontists (AAE) has issued a position statement on the care of patients taking bisphosphonates, recommending that all patients taking these drugs be considered at some risk of developing osteonecrosis of the jaw (ONJ).

Bisphosphonates are used to treat certain cancers and bone diseases such as Paget's disease and osteoporosis. They support the build-up of bone in areas weakened by disease but have the potential side effect of ONJ, in which the opposite effect occurs in the jawbones.

While recognising that the magnitude of risk varies for each patient, the AAE says it is essential that patients taking

bisphosphonates receive advice before undergoing elective dental surgery. Any non-elective dental work, in particular extractions, should be completed before bisphosphonate therapy begins, and patients taking bisphosphonates are encouraged to inform their dental care providers and consult with specialists as needed.

The statement is based on the findings of a special committee assembled by the AAE to review scientific data on the relationship between bisphosphonates and ONJ. Case reports suggest that ONJ in patients taking bisphosphonates may be triggered by tooth extractions and other surgical events, although it can also occur spontaneously.

## BDHF warns against 'dental holidays'

The UK's largest oral health charity is warning patients to think carefully before travelling abroad for dental treatment. The British Dental Health Foundation (BDHF) fears that the current controversy surrounding UK dentistry is leading to drastic action among patients, with more and more travelling abroad to countries such as Hungary to undertake treatment.

The charity's Chief Executive, Dr Nigel Carter, said 'With all the stories in the press focusing on a crisis in UK dentistry it seems that many people are losing faith in the system and looking abroad for cheaper prices. However, before rushing into something as drastic as that, it is important to give careful consideration to the possible risks.'

Dr Carter stressed that patients should consider what they will do if something were to go wrong. 'Even something minor, like adjusting a crown, would require an expensive and probably very inconvenient return flight,' he said. 'Then there is the question of what rights you have as a patient.'

Instead of rushing abroad for treatment, Dr Carter suggests that people shop around a little in their local area first, as they may find that private treatment is not as expensive as they first feared.

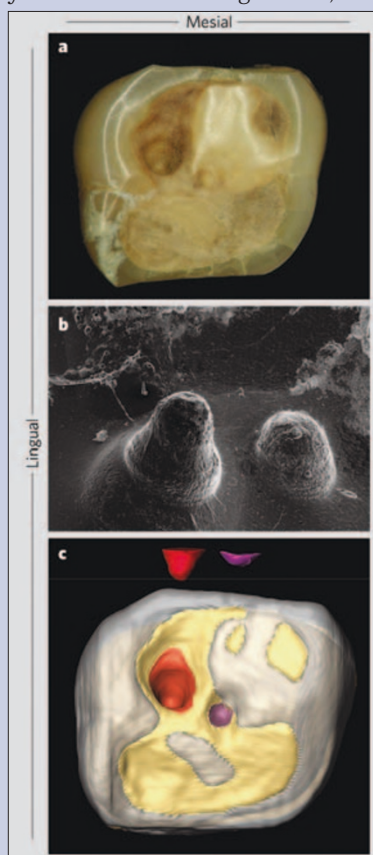


# Stone age 'proto-dentistry' revealed

Dental drilling began earlier than previously thought, according to a recent report in *Nature* (Coppa A, Bondioli L, Cucina A *et al.*, *Nature* 2006; 440: 755-756). An international team of researchers have discovered eleven drilled molars in a Neolithic graveyard in Pakistan dating from 7,500-9,000 years ago, at least 1,500 years earlier than previous evidence of drilled teeth.

The teeth were found at Mehrgarh in Baluchistan province and were drilled using flint drill heads that have been found at the site. Varying in depth from 0.5 to 3.5 mm, the holes were drilled into the enamel or secondary dentine on the occlusal surfaces of the teeth, except for one that was located on the distal-buccal cervix of a lower first molar. The team found evidence of surprisingly complex procedures, with the teeth of at least one individual showing signs of subsequent carving of the cavity wall. Marginal smoothing of the drilled areas confirms that the drilling was performed on live people who continued to chew on the tooth surfaces after they had been drilled.

The eleven crowns were exclusively either first or second permanent molars, a fact that the team says rules out drilling for aesthetic purposes, as the teeth were too far back in the mouth. Although the exact motive for the drilling remains unclear, four teeth show signs of caries associated with the hole, which could indicate that the drilling was for therapeutic or palliative reasons in some cases. The flint drill heads at Mehrgarh were found associated with beads, suggesting that skills developed for bead making were successfully transferred to drilling teeth.

## New implant training standards announced

The Faculty of General Dental Practice (UK) has published essential new guidance that sets out the training standards necessary to practice implant dentistry. *Training Standards in Implant Dentistry for General Dental Practitioners* was produced by the Standards Working Group, convened by the GDC and comprising representatives nominated by leading UK dental bodies.

The Working Group was established in response to concerns about the quality of implant dentistry practised by some dentists and the provision of training in this area. Its aim in setting training standards was to ensure that GDPs who practice implant dentistry are competent to carry out this work. Patient protection was also central to the rationale behind the guidelines, as the Working Group found that training in this area was often provided on an *ad hoc* basis. Hew Mathewson, President of the GDC, said 'When the Council considered the standards and training in implant dentistry in 2004, it became clear that the provision of training in this area was very varied and that the setting of common guidelines was important in the interest of patients - particularly as it is such a new, fast-growing and invasive aspect of dentistry.'

The GDC expects that the document will be used as a benchmark by those who practise implant dentistry. The document is available to download from the FGDP(UK) website at [www.fgdp.org.uk](http://www.fgdp.org.uk) and will also be published in the respective journals and websites of the bodies represented on the Working Group.
