MEETING FEATURES

Plenary Sessions have been organized to highlight a wide range of topics designed to inform genetics practitioners, researchers and counselors. Sessions will feature experts who will describe advances in many areas of interest and importance to research and practice.

HIGH SCHOOL DAY

Once again, the ACMG will be hosting local high school students for an "Introduction to Genetics Session" in conjunction with our Annual Meeting. Junior and senior honor students and their biology and science teachers will be introduced to both the theoretical and practical aspects of genetics, with topics ranging from counseling to molecular diagnosis. Hands-on activities are emphasized, and correlations between clinical presentations and molecular diagnosis will be emphasized. It is the hope that such programs will interest young people early in a career in genetics.

This highly successful outreach program was started a few years ago and is being presented this year by Dr. Lisa Baumbach-Reardon. It is expected that approximately 100 students/teachers will attend. The event will be held on Thursday, March 18, 1999 from 8:30 am-3:00 pm at the Mailman Center for Child Development at the University of Miami Medical School Campus, conveniently located 5 minutes from the convention hotel. Volunteers from the College are still needed to help participants set up PCR reactions and gel electrophoresis, as well as help share in the lecture schedule. ACMG POST-MEETING WORKSHOP March 22, 1999, Regency Ballroom Update on Effective Coding, Billing and Compliance for Clinical and Laboratory Genetic Services

Ms. Charlotte Kohler, RN, CPA, and Ms. Jane Tumpson, MAT, MBA, will present a half-day workshop on billing, collections, coding and compliance for genetic services in the 1999 marketplace. While insurers may identify contract-specific provisions, many payers increasingly adhere to Medicare and Medicaid standards. Additionally, given the increased oversight and enforcement powers provided under federal legislation (HIPPA and BBA), the federal government is now starting to prosecute non-Medicare and Medicaid billing "problems" under the fraud and abuse precepts. This seminar will present the Medicare requirements, third parties' differences, and how to protect your genetics programs against billing complaints.

Genetics programs differ according to where and how they deliver services. Some programs exist in a hospital or university setting under its corporate structure. Some are affiliated with these organizations, while others are autonomous and independent. In this workshop, we will clearly present what the different ownership structures indicate in terms of use of staff, and requirements for proper billing of services provided. We will also discuss the use of credentialed providers who are not physicians, and how to bill for their services.

HCFA and the AMA maintain significant differences on the documentation requirements for certain levels of the Evaluation and Management (E & M) coding. These differences and the code changes and new codes for 1999 will be presented by the consultants.

This workshop will provide a valuable update to a broadbased audience: practice and laboratory managers, genetic counselors and physicians will all benefit. We welcome specific case studies or questions from those who attend. Please submit examples and questions with your registration form at least two weeks prior to the seminar if you wish for the consultants to research them and present findings at the workshop. Note that March 1 is the deadline for advance registration at lower rates.
