Developmental Genome Anatomy Project (DGAP)—Patients with apparently balanced chromosomal rearrangements and multiple congenital anomalies are being sought for participation in a gene discovery research project. The goals of the Developmental Genome Anatomy Project (DGAP) include FISH mapping of chromosomal breakpoints, positional cloning of genes interrupted or dysregulated at the breakpoints, and validation of genes identified in specific anomalies through the creation of animal models or mutation analyses of appropriate patient populations.
