### **Navigating the Shifting Tax** Landscape - IRAs

An excellent article in the New York Times on February 17, 2010, Navigating the Shifting Tax Landscape, details some of the current tax traps, pitfalls, and uncertainty - specifically traditional IRAs and Roth IRAs.

Traditional IRAs grow tax-free until withdrawals are made. But Roth IRAs are created with after-tax assets: that means people can use Roth IRAs to set aside money to tap into tax-free at a later date - or pass along those assets tax-free to their heirs, an attractive option for many wealthy individuals.

Starting this year, people whose incomes were too high to qualify for Roth IRAs in the past can now take advantage of them. But anyone shifting money from a traditional IRA to a Roth IRA must pay taxes on the money. This year alone, they have the option of spreading the taxes across their 2011 and 2012 tax returns.

Charitable giving, like to the ACMG Foundation, can help offset some of that tax liability. The New York Times article provides an illustration of how a donor who shifts \$100,000 into a Roth IRA can save 16 percent of the \$35,000 he would owe in taxes by using some of the money to set up a charitable gift annuity.

Not only would the arrangement provide the donor's heirs with nearly \$75,000 tax-free at his or her death; it would also provide a small income stream to the donor during his or her lifetime. And money left over in the annuity, an estimated \$42,000, would go to the Foundation or a charity of the donor's choosing.
