Tuning the band structure and superconductivity in single-layer FeSe by interface engineering

The interface between transition metal compounds provides a rich playground for emergent phenomena. Recently, significantly enhanced superconductivity has been reported for single-layer FeSe on Nb-doped SrTiO₃ substrate. Yet it remains mysterious how the interface affects the superconductivity. Here we use *in situ* angle-resolved photoemission spectroscopy to investigate various FeSe-based heterostructures grown by molecular beam epitaxy, and uncover that electronic correlations and superconducting gap-closing temperature (T_g) are tuned by interfacial effects. T_g up to 75 K is observed in extremely tensile-strained single-layer FeSe on Nb-doped BaTiO₃, which sets a record high pairing temperature for both Fe-based superconductor and monolayer-thick films, providing a promising prospect on realizing more cost-effective superconducting device. Moreover, our results exclude the direct correlation between superconductivity and tensile strain or the energy of an interfacial phonon mode, and highlight the critical and non-trivial role of FeSe/oxide interface on the high T_g , which provides new clues for understanding its origin.

The high-superconducting transition temperature (T_c) in cuprate superconductors is hard to preserve in ultra-thin films as the monolayer limit approaches¹. On the contrary, FeSe films grown on SrTiO₃ substrates show an enhanced T_c with monolayer thickness^{2,3}. *Ex situ* transport measurements of single-layer FeSe films (SLFs) grown on SrTiO₃ substrates (referred as FeSe^S hereafter) with capping layers show an onset T_c of ~ 40 K (ref. 4), much higher than the 8 K bulk value. Although the true T_c of FeSe^S remains to be confirmed by *in situ* transport measurements, *in situ* angle-resolved photoemission spectroscopy (ARPES) studies found a $T_g \sim 65$ K (refs 5,6). This is the record high Cooper-pair-formation temperature among iron-based high-temperature superconductors (Fe-HTSs) and superconducting films at monolayer limit. It encourages further effort to increase T_g above the liquid nitrogen boiling temperature, so that more cost-effective applications could be expected. One way is to explore different interfaces between FeSe and various oxides that would also provide more clues to understand the origin of the remarkable interfacial superconductivity in SLFs and high-temperature superconductivity in general.




Figure 1 | The structures and Fermi surfaces of FeSe/Nb:BaTiO₃/KTaO₃ films. (a) The schematic cross-section of the FeSe/Nb:BaTiO₃/KTaO₃ films. For FeSe^{BU}, 0.5 layer of BaO is inserted to eliminate the 3×3 superstructure as indicated. The LEED patterns for the Nb:BaTiO₃/KTaO₃ films before and after the 950 °C heat treatment under Se flux are shown on the bottom. (b) Left: the Fermi surfaces of FeSe^B as represented by the photoemission intensity map at the Fermi energy. The intensity was integrated over a window of $(E_F, E_F - 20$ meV). Right: its LEED pattern. Besides the main spots that reflect the unrelaxed lattice of the substrate (indicated by the blue square), there are spots corresponding to two $\pm 18.5^\circ$ rotated lattices (indicated by the yellow squares). Correspondingly, there are three sets of Fermi surfaces whose respective Brillouin zone are derived based on the high symmetry points. (c) Left: the Fermi surfaces of FeSe^{BR} resulting from post-annealing FeSe^B, where only two sets of Fermi surfaces are observed, corresponding to the two $\pm 18.5^\circ$ rotated lattices. Right: its LEED pattern, where the main spots are weakened, and the spots for the rotated lattices are enhanced. (d) Left: the Fermi surfaces of FeSe^{BU}, where only the elliptical Fermi surface sheets are observed. Right: its LEED pattern. No superstructure spots are observed and the lattice is unrelaxed. (e) Sketches for the lattices of various FeSe/Nb:BaTiO₃/KTaO₃ films.

A burst of researches have been conducted recently on FeSe^S, suggesting that the high T_c might originate from epitaxial strain, interfacial electron-phonon coupling and/or charge transfer^{6–10}. Here we directly manipulate these interfacial factors by heterostructure design. We have fabricated (1) SLFs with extremely expanded in-plane lattice of ~ 3.99 Å while preserving FeSe/SrTiO₃ interface by epitaxially growing FeSe/Nb:SrTiO₃/KTaO₃ heterostructures (hereafter referred as FeSe^{SX})¹¹; (2) SLFs with extremely expanded in-plane lattice of ~ 3.99 Å and with slightly expanded in-plane lattice of 3.78 Å, but changing the interfacial oxide to Nb-doped BaTiO₃ by epitaxially growing FeSe/Nb:BaTiO₃/KTaO₃ heterostructures (Fig. 1a, hereafter referred as FeSe^B); and (3) multi-layer Fe_{1-x}Co_xSe films (hereafter referred as FeCoSe^{SR}), which are heavily electron doped similar to FeSe^S but much thicker than SLFs. *In situ* ARPES studies were conducted on all these films to directly illustrate how the electronic structures and corresponding T_g of FeSe films are affected by the interface. We demonstrate a record high Cooper-pair-formation temperature up to 75 K on FeSe^B, extending the high-temperature superconductivity to new interfaces. Moreover, we found that the couplings between SLFs

with the interfacial oxides renormalize the band structures in a non-trivial way. The band mass around the Brillouin zone centre is enhanced for SLFs with expanded lattice owing to the decrement of hopping terms, but the renormalization factor depends on the type of oxide substrate. On the other hand, the bandwidth of the electron-like bands around the Brillouin zone corners are negligibly affected. Furthermore, we exclude the direct relation between superconductivity and tensile strain, or the energy of an interfacial phonon mode, and demonstrate the crucial and non-trivial role of FeSe/oxide interface on the high T_g . These results yield new microscopic insights into the high T_c and provide clues for further enhancing T_c through interface engineering.

Results

Two SLF domains of FeSe^B with distinct in-plane lattices. As shown by the *in situ* low-energy electron diffraction (LEED) patterns of the epitaxial Nb:BaTiO₃ (Fig. 1a), 3×3 surface reconstruction shows up after the heat treatment before SLF growth. From the photoemission spectral mapping and LEED image of FeSe^B (Fig. 1b), we found that the reconstruction has a direct impact on the deposited SLFs by generating three spatially separated domains. One domain preserves the lattice of the KTaO₃ substrate, as highlighted by the blue square in the LEED pattern (Fig. 1b). The corresponding Fermi surfaces are elliptical (Fig. 1b), similar to those observed in FeSe^{SX} (ref. 11). The other two domains are rotated about $\pm 18.5^\circ$, as highlighted by the two yellow squares in the LEED pattern (Fig. 1b), and the corresponding Fermi surfaces consist of more circular sheets, similar to those observed in FeSe^S. The in-plane lattice constant a of each domain could be derived from the inverted Brillouin zone size determined by high symmetry points of photoemission map⁶, which is 3.99 Å for the unrotated lattice and 3.78 Å for the rotated ones. As shown in Fig. 1e, these three domains of FeSe^B match the reconstructed period. Particularly, every 10 periods of the rotated FeSe lattice match the diagonal of a 3×9 rectangle of the Nb:BaTiO₃ lattice (the dashed line in Fig. 1e). Based on the calculated Luttinger volume, there are 0.12 excessive electrons per Fe for all these domains, similar to FeSe^S and FeSe^{SX}. The $\pm 18.5^\circ$ rotated domains could be further enhanced (Fig. 1c; such domains are referred as FeSe^{BR} hereafter) with post annealing

for over 15 h, while the unrelaxed domain could be enhanced (Fig. 1d; such a domain is referred as FeSe^{BU}) by insertion of extra BaO layer in Nb:BaTiO₃ film (Fig. 1a). In this way, the electronic structures and corresponding T_g can be compared in different domains of FeSe^B with the lattice constant as a clean control parameter.




Figure 2 | The band structures around the zone centre of various FeSe films. (a,b) The photoemission intensity along #BU1, #BR1, #SX1 and #S1 across Γ (a(i-iv)), and the corresponding second derivative with respect to energy to highlight the dispersions (b(i-iv)) for FeSe^{BU}, FeSe^{BR}, FeSe^{SX} and FeSe^S, respectively. The momentum location of the cuts are shown in the top-right inset. (c) Comparison of the dispersion of band α from ARPES data and the DFT calculated band structures along the Γ -M' direction. The blue markers show the experimental dispersions and the red curves show the corresponding parabolic fittings. The energy scales of the calculated band structures at the right side are several times of the energy scales of the experimental data at the left, and the corresponding renormalization factors are shown. The #BU1 and #BR1 data were taken at 45 K, whereas others were taken at 30 K. (d) The energy separations between the α and ω bands at Γ versus a . The energy separation is defined in b(i). (e) Effective mass m^* of band α as a function of in-plane lattice constant a , where m_e is the free-electron mass. The effective mass is determined by parabolic fitting of the band dispersion of band α . The error bars for band separation and effective mass are determined by the combination of energy resolution, fitting errors and deviations between samples. The error bar for a is owing to the uncertainty in determining the Brillouin zone size from features with finite width. We note that the slight rotation of the cuts does not affect the quantitative conclusions here (Supplementary Fig. 1).

Interface-induced band structure evolution. In Fig. 2, we present the band dispersions for various SLFs grown on Nb:BaTiO₃ or Nb:SrTiO₃. Around $\Gamma(0,0)$, the generic features for all films include a parabolic band α and a relative flat band ω at higher binding energy (Fig. 2a,b). Since the bands around zone centre are nearly isotropic, the photoemission cuts with different in-plane angles are comparable (Supplementary Fig. 1). For the two films grown on Nb:BaTiO₃, the larger a corresponds to a larger effective mass of band α , and smaller energy separations between the two bands (Fig. 2b(i,ii)). The same holds true for the two SLFs grown on Nb:SrTiO₃ (Fig. 2b(iii,iv)). Density functional theory (DFT) calculations were performed for FeSe^{SX} and FeSe^S, showing that the band mass and band separation indeed increases with the expanded lattice (Fig. 2c(ii,iii)), similar to the experimental results. Quantitatively, we scale the measured bands to the calculated ones, and get the same renormalization factor of 5.0 for both FeSe^{SX} (Fig. 2c(ii)) and FeSe^S (Fig. 2c(iii)). Therefore, the quasiparticle bandwidth narrowing with enhanced tensile strain could be fully attributed to a pure band effect, that is, the decrement of the hopping integral t . Consequently for such an

iron-based superconductor, the electronic correlation strength is enhanced with the expanded lattice, since it could be represented by either J_H/t (refs 12,13) or J_2/t (ref. 14; J_H being the on-site Hund's rule coupling constant, and J_2 being the next-nearest-neighbour exchange coupling parameter).

Intriguingly, even though both the Nb:BaTiO₃/KTaO₃ and Nb:SrTiO₃/KTaO₃ provide similar amount of electrons to SLFs and posses the same tensile strain with $a = 3.99 \text{ \AA}$, there are clear differences in the band dispersions for FeSe^{SX} and FeSe^{BU} (Fig. 2b(i,iii)). The bands are flatter for SLFs on Nb:SrTiO₃ than that for SLFs on Nb:BaTiO₃. However, in our DFT calculations, the calculated band structure for FeSe^{BU} is similar to that of FeSe^{SX} (Fig. 2c(i,ii)), which could not account for the band mass variation with different interfacial oxides as observed in our experiments (Fig. 2b(i,iii)). The renormalization factor between the measured α band and the calculated one is 4.3 for FeSe^{BU} (Fig. 2c(i)), which is smaller than that of FeSe^{SX} (Fig. 2c(ii)). Therefore, the bandwidth variations for SLFs on different oxides are beyond the pure lattice-expansion effect, and there should be additional correlation effects that depend on the interface. As summarized in Fig. 2d,e, the two characteristic quantities (band mass and band separation) fall on two separate curves as a function of a , which clearly indicates that the interfacial oxide material has non-trivial effects on the electronic correlation of the epitaxial SLFs.




Figure 3 | The band structures around the zone corner of various FeSe films. (a,b) The photoemission intensity along #BU2, #BR2, #SX2 and #S2 across M' (a(i-iv)), and the corresponding momentum distribution curves (b(i-iv)) for FeSe^{BU} , FeSe^{BR} , FeSe^{SX} and FeSe^{S} , respectively. The momentum locations are illustrated in the top-right inset of Fig. 2. (c–e) Energy distribution curves (EDCs) across $M(M')$ for FeSe^{S} , FeSe^{BR} and FeSe^{SX} , respectively, which show band replication behaviour. The markers are local maximum locus to indicate the band position, and the replica bands are labelled as γ_1'/γ_2' or γ_2' considering the band degeneracy and matrix element effects¹¹. The energy separations between the main band and the replica band are shown as E_M for different SLFs to represent the energy scales of the phonon modes. The data were taken at 30 K.

The different interfacial oxides and strains affect the band structure around M ($\pi,0$) as well, but in a different non-trivial manner (Fig. 3a,b). For FeSe^{BR} and FeSe^S with smaller in-plane

lattices, the two γ_1 and γ_2 bands are degenerating (Fig. 3b(ii,iv)). For the large $a=3.99\text{ \AA}$, two γ_1 and γ_2 electron bands are resolved for FeSe^{BU} and FeSe^{SX} but with different separations between them (Fig. 3b(i,iii)). Remarkably, unlike the different renormalizations of the α band, the bandwidths of the electron bands are similar in all these films.

Replica bands near M and interfacial phonon energy scale. At higher binding energies, replicas of the electron bands (those of γ_1 and/or γ_2 bands considering the band degeneracy and matrix element effects¹¹) can be resolved in FeSe^{S} , FeSe^{BR} and FeSe^{SX} (Fig. 3c–e) near M. Such band replication behaviour was observed in FeSe^{S} , which has been shown to be very likely a shake-off satellite band by an interfacial oxygen optical phonon mode¹⁰. In ref. 10, a sophisticated spectral lineshape fitting was exploited to retrieve the energy of this phonon, and its coupling strength to

the electrons. However, since the intensity ratio between the replica bands and the corresponding main bands are influenced by the photoemission matrix element effect and sample quality, we could not directly extract the coupling strengths at different interfaces from our data. Nevertheless, one could take the energy separation between the main band and the replica band to represent the energy scale of the phonon mode, E_M , which is 98, 92 and 87 meV for FeSe^{S} , FeSe^{BR} , and FeSe^{SX} , respectively (Fig. 3c–e).




Figure 4 | Temperature dependence of the superconducting gaps for different FeSe films. (a) The symmetrized EDCs for FeSe^{B} along cut #B1 as indicated in the bottom-right inset. The circles mark the dispersion. The thick EDC curve is at the normal state Fermi momentum (k_F) of the FeSe^{BU} domain. (b) Temperature dependence of the symmetrized EDC at the marked k_F for FeSe^{B} . The coherent peak positions are marked by triangles. (c,d) Similar as a,b, but for FeSe^{BR} film. (e) The superconducting gap determined as a function of temperature from data in b,d. The solid and dashed curves are the fits by the Bardeen–Cooper–Schrieffer gap-temperature formula. (f) The maximal low-temperature gap versus T_g plot, including the values for $\text{K}_x\text{Fe}_{2-y}\text{Se}_2$ bulk³¹, FeSe^{S} (ref. 6) and FeSe^{SX} (ref. 11). Note that for FeSe^{SX} and FeSe^{B} , the maximal values of the anisotropic gap distributions are used. The error bars of temperature are from the measurement uncertainty, and those of gap are from the s.d. of the fitting process.

Cooper-pair-formation temperature. The superconducting properties of the various SLFs are examined in Fig. 4. Figure 4a shows the symmetrized energy distribution curves (EDCs) at low temperature along cut #B1 across the Fermi surfaces of the unrotated domains of FeSe^{B} . The dispersion exhibits a characteristic bending back behaviour after passing the Fermi momentum. This is a hallmark of Bogliubov quasiparticle dispersion, and indicates that the gap is due to Cooper-pair formation. The gap amplitude of FeSe^{B} shows anisotropic distribution along the elliptical Fermi surfaces of the unrotated domain (Supplementary Fig. 2), which is consistent with our previous results on FeSe^{SX} (ref. 11). The symmetrized EDCs at the normal state Fermi momenta could be used to identify the gap by the spectral weight suppression at E_F , which is minimally

affected by the temperature broadening effects¹⁵. Figure 4b presents the temperature dependence of the symmetrized EDCs at the Fermi momentum for the unrotated domains in FeSe^B, and the gap decreases with increasing temperature and eventually closes above 73 K. In Fig. 4c,d, we show the gap behaviour of FeSe^{BR}, and the gap closes above 68 K. The data for FeSe^{BU} shows rather weak coherence peaks, but with possible signs for T_g above 77 K (Supplementary Fig. 3).

The temperature dependence of the gap is shown in Fig. 4e, which could be well fitted by the Bardeen–Cooper–Schrieffer gap versus temperature formula. This further suggest that the gap-opening relates to the Cooper-pair formation, although *in situ* transport is needed to check if $T_c = T_g$. The fitted T_g is 75 ± 2 K, and 70 ± 2 K for FeSe^B and FeSe^{BR}, respectively. The former sets a record high T_g for Fe-HTSs and monolayer-thick films. Figure 4f summarizes the maximal gap versus T_g for FeSe films and $K_x\text{Fe}_{2-y}\text{Se}_2$. One can find a monotonic and generally linear trend between T_g and the gap amplitude, with $2\Delta/k_B T_c \sim 6.0$, demonstrating the relatively strong coupling superconductivity and the similar superconducting nature in these materials.




Figure 5 | Electronic structure of FeCoSe^{SR}. FeCoSe^{SR} is a Co-doped 35-u.c.-thick FeSe film with partially relaxed lattice. (a,b) The photoemission intensity (a) and the corresponding second derivative with respect to energy to highlight the dispersions (b) along cut #SR1. (c,d) The photoemission intensity along cut #SR2 and cut #SR3, respectively. (e) Photoemission intensity map at E_F for FeCoSe^{SR}, which is integrated over ($E_F + 10$ meV, $E_F - 10$ meV), where the momentum cuts for data in other panels are marked. (f,g) The symmetrized EDCs along a portion of cut #SR2 (f) and cut #SR3 (g), as indicated by the blue arrows in c,d, respectively. The dispersions are marked by the red triangles. The data were taken at 30 K.

Crucial role of FeSe/oxide interface on the high T_g . Considering that high T_g seems robust in all these SLFs, especially in FeSe^{BR} whose a is close to that of bulk FeSe (3.765 Å), it is intriguing to check whether thick FeSe films with the same a and similar electron doping of FeSe^{BR} would also hold high T_g . We have grown 35-unit cell (u.c.)-thick FeCoSe^{SR} on Nb:SrTiO₃ with the electron carriers introduced by Co doping, and its a is relaxed to 3.78 Å as derived from the inversed Brillouin zone size⁶. As shown in Fig. 5a,b, the hole pockets formed by bands α and β sink below the Fermi energy, and the electron Fermi surfaces are fairly

large as shown in Fig. 5c–e. About 8% electrons could be doped, which is limited by the solubility of cobalt. The symmetrized EDCs at 30 K across the electron Fermi surfaces are shown in Fig. 5f,g, however, without any sign of a superconducting gap. The T_g , if any, is below the lowest temperature of 30 K that could be reached at the current experimental setup. If the superconductivity had been originated only from the FeSe layer, one would expect a higher T_g in FeCoSe^{SR} owing to suppressed two-dimensional (2D) fluctuations in thick films, which is not observed in our experiments. This demonstrates the dominating role of the FeSe/oxide interface on the high T_g in FeSe/Nb:SrTiO₃ or FeSe/Nb:BaTiO₃. In thick FeCoSe^{SR} films where interfacial effects are negligible, the absence of a gap or a small T_g is expected, since heavy electron doping would bring the system to the overdoped regime, where superconductivity diminishes as observed for bulk Fe-HTSs^{16,17}.

Discussion




Figure 6 | The relation between T_g and various parameters. (a) T_g as a function of in-plane lattice constant a . The T_g of FeCoSe^{SR} is below the lowest temperature of 30 K that could be reached at the current apparatus. Since FeCoSe^{SR} is overdoped with essentially no interface effects, its T_g should be lower than the bulk FeSe T_c of 8 K, assuming that it possesses the common superconducting dome of Fe-HTSs. Here we expect its T_g at 4 K, with the error bar between 0 and 30 K. The other error bars of T_g are from the measurement uncertainty, and those of a are owing to the uncertainty in determining the Brillouin zone size from features with finite width. (b) T_g as a function of the effective mass of band α at the zone centre. The error bars of effective mass are determined by the combination of energy resolution and fitting errors. (c) T_g versus the energy scale of the phonon mode represented as E_M . The error bars of E_M are determined from the experimental resolution. (d) Illustration of three possible pairing mechanisms for the high T_g in SLFs.

Our results help to elucidate and/or exclude some of the interfacial effects on the superconductivity in SLFs. Particularly, the interfacial tensile strain has been proposed to be a critical factor⁶ that normally would significantly enhance the antiferromagnetic superexchange interactions across the Fe–Se–Fe⁸. However, with the lattice expansion by 5.5% in FeSe^{BU} compared with FeSe^{BR}, T_g is enhanced by only 5 K (Fig. 6a), surprisingly small in the context of the antiferromagnetic-interaction/spin fluctuations-mediated superconductivity, which is arguably the current dominating picture for bulk Fe-HTSs¹⁸. The lattice expansion from FeSe^S to FeSe^{SX} induces small T_g enhancement as well¹¹. Therefore, the tensile strain imposed by the oxide layer is a positive but not a major factor for the high T_g in SLFs. In addition, as shown in Fig. 6a, the large T_g enhancement from FeCoSe^{SR} to FeSe^{BR} is due to interfacial effects beyond tensile strain, since they have the same in-plane lattice.

The correlation between T_g and the complex interfacial effects on the band renormalizations around Γ and M deserves further examination. The correlation strength deduced from the α band varies with different interfacial oxides and tensile strain, as indicated by the effective mass in Fig. 2e. However, as shown in Fig. 6b, T_g does not monotonically correlate with the quasiparticle mass of the α band. This is not surprising as α is fully occupied and does not contribute to pairing. Intriguingly, for the partially occupied electron-like bands around M that contribute to pairing, their band bottoms are all around -60 meV for the same doping of $0.12e^-$ per Fe in different SLFs (Fig. 3), giving almost identical bandwidth for the electron bands in these SLFs, although their Fermi velocities could not be directly compared owing to the different band degeneracies. The nearly same bandwidth for the partially occupied electron bands may relate to the robust high-superconducting gap-closing temperatures in these SLFs¹⁹.

With the above observations, one could speculate some intriguing and non-exclusive possibilities as illustrated in Fig. 6d. For example, the polarizability of the ions in the oxide layer induces interfacial electron–phonon interactions²⁰. Consistently, we have observed the general presence of the related replica band (Fig. 3c–e) at the SLF/oxide interfaces. The high-frequency phonons and strong electron–phonon interactions in Nb:SrTiO₃ or Nb:BaTiO₃ may mediate superconductivity as proposed in ref. 9. However, Fig. 6c clearly rules out the direct correlation between E_M and T_g . Further direct evidence is required to see whether the electron–phonon coupling strength or the combination of the coupling strength and phonon energy would correlate with T_g . Another possibility is that the pairing is mediated by certain antiferromagnetic interaction J in SLFs, which sets the

scales of both the superconducting gap and T_g . If so, our results demonstrate that there is a non-trivial enhancement from the FeSe/oxide interface to J , which is beyond the simple tensile strain effects, and may be manifested in the relatively unchanged bandwidth of the electron-like band around M . In addition, we did not find any noticeable dependence of the electronic structure and superconducting properties on the Nb concentration (that is, conductivity and carrier density in the oxide layer). Therefore, it is not likely that the superconductivity in SLFs is mediated by the electronic polarizability of the substrate following the picture proposed by Little²¹ and Ginzburg²². Nevertheless, the electronic polarizability of the substrate would help to screen the Coulomb interactions at various ranges²³, thus facilitate pairing²⁴. In fact, the observed interfacial oxide dependence of correlations in SLFs may be resulting from the different screening of the interactions by Nb:SrTiO₃ and Nb:BaTiO₃.

Methods

Thin film growth. Before oxide thin film growth, (001) oriented KTaO₃ substrates were etched with buffered NH₄-HF solutions and annealed in 2 bar pure oxygen to get atomically smooth surface. Oxide thin films (including 5% Nb-doped BaTiO₃

films, 5% Nb-doped SrTiO₃ films and 0.5% Nb-doped SrTiO₃ films) were grown with ozone-assisted molecular beam epitaxy following the shutter-controlled layer-by-layer growth method: the A site material (Ba or Sr) and B site materials (Ti and Nb) were deposited alternatively, while Ti and Nb were co-deposited to get uniform doping²⁵. The relative stoichiometry and absolute amount of each element were based on quartz crystal microbalance measurements and the real-time reflection high-energy electron diffraction oscillation method described in ref. 25. During the growth of oxides, the reflection high-energy electron diffraction pattern retained its 2D character. With the shutter-controlled growth mode²⁵, the films were terminated with TiO₂ layer after the growth of each unit cell. The oxide films were typically 40-u.c. thick. Nb doping is induced, and silver paste was attached on the substrate edge in order to improve the conduction of oxide layer and avoid charging effect during photoemission measurements.

After the growth of oxides, the heterostructures were transferred under an ultra-high vacuum to another molecular beam epitaxy (MBE) chamber, where they were heated to 950 °C with Se flux for 30 min. FeSe films were co-deposited with the Se flux 20 times greater than the Fe flux while the substrates were kept at 450 °C. FeCoSe^{SR} films were grown directly on TiO₂-terminated Nb:SrTiO₃ substrates with 8% amount of Fe substituted by Co. Afterwards, the films were annealed at 600 °C in vacuum for 3 h and directly transferred into the ARPES chamber. Longer annealing increases the relaxed domain (FeSe^{BR}) in FeSe^B and improves film quality in most cases, while it does not notably change the band structure.

ARPES measurement. ARPES data were taken *in situ* under ultra-high vacuum of 1.5×10^{-11} mbar, with a SPECS UVLS discharge lamp (21.2 eV He-I α light) and a Scienta R4000 electron analyser. The energy resolution is 8 meV and the angular resolution is 0.3°. Data were taken at 30 K if not specified otherwise. To eliminate the photoemission charging effect due to insulating KTaO₃, silver paste was attached on the substrate edge before growth.

First-principles calculations. To study the electronic structure of FeSe monolayers, we used the first-principles calculations by the projector augmented wave method²⁶ implemented in Vienna Ab-initio Simulation Package (VASP) package^{27,28}. We adopted the generalized gradient approximation of Perdew–Burke–Ernzerhof for the exchange–correlation potentials²⁹. The kinetic energy cutoff of the plane-wave basis was set to be 400 eV after the full convergence test. The optimization made the forces on all relaxed atoms smaller than 0.01 eV/Å. To model the band structure of FeSe monolayer on top of TiO₂-terminated SrTiO₃(001), a six-layer SrTiO₃(001) slab was used with the FeSe monolayer adsorbed on the top side in a $a \times a$ 2D u.c. plus a vacuum layer of 10 Å, while setting the lattice parameters to $a = 3.905$ and 3.989 Å for FeSe^S and FeSe^{SX}, respectively. The top two slab layers and all FeSe layer atoms were allowed to relax, whereas other slab layers were fixed at their original positions. A 12×12 k -points mesh for the Brillouin zone sampling and a width of 0.1 eV Gaussian smearing were used. The electric field induced by asymmetric atomic relaxation was compensated by a dipole correction³⁰. To model FeSe^{BU}, same method was used except changing the six-layer SrTiO₃(001) slab to six-layer BaTiO₃(001) slab. Owing to its large unit cell, we were not able to calculate the band structure of FeSe^{BR}.
