In the version of this article initially published, the citation of Figure 3 in the second paragraph of the third subsection (Chromatin: the nexus of phenotype and the environment) is incorrect. In the HTML version of this article initially published, the scale bar was missing from the inset in the top right image in Figure 2d; the bottom left plot in Figure 2e was incorrectly a duplicate of the adjacent plot at right; and the designations in Figure 4b (*Sall1*<sup>fl/fl</sup> and *Sall1*<sup>CreER/fl</sup>) should have been *Sall1*<sup>fl/fl</sup> and *Sall1*<sup>CreER/fl</sup> (respectively). Also, the arrows in the designations above and below the plots in Supplementary Figure 3b were rendered as boxes; these should have been as follows: *Sall1*<sup>+/+</sup>→*Cx3cr1*<sup>CreER</sup>-iDTR and *Sall1*<sup>GFP/+</sup>→*Cx3cr1*<sup>CreER</sup>-iDTR. Finally, in Supplementary Figure 4f, the red (Ki67<sup>+</sup>) cells in the right set of images were not visible. These errors have been corrected for the HTML version of this article.

In the version of this article initially published, the word ‘products’ was misspelled (as ‘prducts’) in the final sentence of the third paragraph of the introduction; in Table 1, the third column was incorrectly labeled ‘FDR’ instead of the correct ‘Genes in set’; the citation in the penultimate sentence of paragraph 1 of the third Results subsection (Chemokine and homing receptors) was incorrectly noted as a Supplementary Figure and should be cited as “(Fig. 3b)” instead; in Figure 5f, the *P* values defining the horizontal dashed lines were not visible and should be moved right for greater visibility, and each is *P* = 0.05; and in the legend to Figure 6b, ‘CPM’ was incorrectly defined as ‘counts per minute’ instead of the correct ‘counts per million’.
