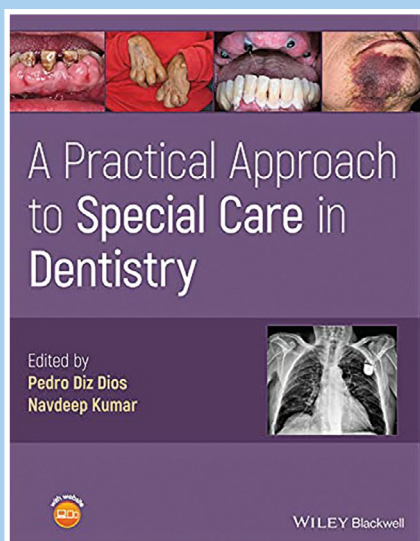

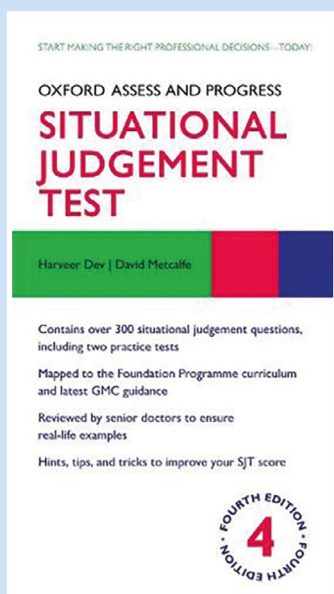


[A Practical Approach to Special Care in Dentistry](#)

This book covers the treatment of dental patients with disabilities or those who are medically compromised. *A Practical Approach to Special Care in Dentistry* delivers an overview of special care dentistry reflecting the most common compromised clinical conditions you will encounter in practice. Using a problem-based learning approach to more than 50 topics based on real-world clinical cases, the authors help the reader to apply knowledge in a clinical case context. Each chapter contains a case report establishing the main risk factors,

followed by a practical set of adaptations to minimise potential complications for their patient. The book includes an introduction to patients with disabilities, including physical disabilities like cerebral palsy and epilepsy, and cognitive impairments. It also explores the treatment of medically compromised patients such as those with infectious diseases, endocrine diseases, hepatorenal disease, and cardiovascular disease. Discussions of other special patient situations, like those with allergies, antiresorptive and antiangiogenic drugs, terminal patients, underhoused patients, and pregnant or breastfeeding patients are also featured.

Now in its fourth edition, *Oxford Assess and Progress: Situational Judgement Test* is the definitive guide for students preparing to sit the Situational Judgement Test (SJT). It features over 300 practical questions in five categories: commitment to professionalism, coping with pressure, effective communication, patient focus and working effectively as part of a team. All scenarios are based on real experiences informed by candidates who have sat the SJT to ensure that the questions closely mirror the content of the real exam. There are two practice tests with a mix of question types (e.g. multiple choice or ranking), content (e.g. domain-tested), and

styles (e.g. patient, colleague, or personal), which allow candidates to prepare for exam day and practice their timings – one of the biggest challenges in the examination. Written by junior doctors and overseen by experts in assessment, this guide demystifies the SJT, allowing you to achieve the best possible score and take control of the first stage of your career.
