Every member of the dental team will have had different experiences of the pandemic and lockdown, but I think all of us will remember vividly how we spent this period for many years to come.

One group with extremely contrasting experiences is dental nurses; as dental journalist Caroline Holland puts it, dental nurses' experiences have ranged from 'heroism to hardship'.
