## **BARRIE NOWELL GOODE**



Barrie Goode, who died on 24 January 2008, was a life member of the BDA. Born in 1935, he studied dentistry at Guy's hospital from 1954-1959, obtaining his LDS

and then BDS. He then did his national service in the RAF, signing on for three years so that he could marry Sheila who had studied physics at University College, and so he enjoyed working at RAF Upavon in Wiltshire and RAF Geilenkirchen and Duren in Germany. On returning to England he worked in general practice in Sevenoaks for 21 years and then in Tonbridge for 16 years where he was a very well loved dental surgeon, a gentle giant, who helped many overcome their fear of the dentist. He loved his work and for him it was his Christian service.

During this time he lived in Tunbridge Wells and was active in dental politics for 24 years, firstly on the Local Dental Committee and then on the GDS Committee for the last 15 of these years (only the last nine of these were paid). He was on the executive of the GDSC, a manager of the Dental Guild, on the Women in Dentistry working party and on the Dental Rates study group for five years. He represented Kent on the central committee for LDCs serving as vice chairman and chairman of Conference in 1990. He believed in the NHS, for which he always worked, was delighted with the agreement reached in the new contract when early retirement and a fair scale of fees was agreed and very disappointed when the government reneged

on this and so many dental surgeons then went private and opted out of the health scheme.

It amused him to be a cross delegate to the GMC as his son Andrew became a medical doctor and also studied at Guy's Hospital, qualifying in 1989 and now practising near Reading. Barrie's daughter Kirsten worked with him as a dental nurse for 12 years and now lives in Norway with her family.

A man of enthusiasm, happily married for 48 years, Barrie really enjoyed his family - including four grandchildren - his boat, painting, golf, birds, music and the countryside. Retirement to Ferndown near Poole was a joy and his faith and membership of St Mary's enabled him to face his chemotherapy serenely and to relish every minute of his time with family and friends.
