

## CAUSE FOR APPLAUSE

Peter and Fiona Sands, of Saint Helens Dental Practice, Abingdon, will be two of around 300 cyclists cycling over 300 miles from London to Paris in aid of The Royal British Legion in September. The Sands hope to raise over £5,000 to help the Legion, which supports serving and ex-Service men and women and their dependants.

## NEW SCHEME OFFERS FINANCE TO GO GREEN

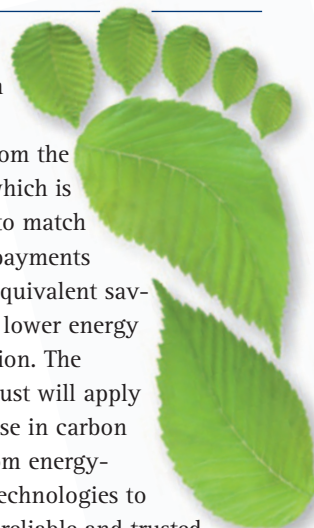

## WIGAN DENTIST COMPLETES IRON MAN CHALLENGE

Barry Rimmer from Ashton Dental Practice in Wigan completed a grueling Ironman endurance event in July.

The event involved a 2.4 mile swim followed by a 112 mile bike ride then a 26.2 mile marathon. To challenge himself further, Mr Rimmer wore only thin 'Five Fingers' trainers on his feet. He raised close to £5,000 to go towards funding for schools and vital equipment for a village in Zambia.
