GDC ANNOUNCEMENTS

- The GDC is urging DCPs to keep track of their CPD and to ensure they keep hold of any attendance certificates they have received. For CPD to be counted as verifiable you must get and keep a certificate and the activity must have concise educational aims and objectives, clear anticipated outcomes and quality controls (you should have the chance to give feedback).
- ⇒ The GDC says that CPD, both verifiable and non-verifiable (general) can be found through the following sources: formal courses and lectures; in-house team training; study days; educational parts of professional meetings; peer review and clinical audit; distance learning; multimedia learning such as web-based learning and using a CD-ROM; staff training in the practice or laboratory; going to educational workshops and conferences; and reading journals and magazines.
- ⇒ There is still time to have your say on the issue of direct access, that is, patients being able to see a member of the dental team such as a dental hygienist or dental therapist without seeing a dentist first. A literature review conducted by the GDC in April 2012 established that there was no evidence of significant issues of patient safety resulting from the clinical activity of DCPs, and that there was evidence that access to dental care improved as a result of direct access arrangements. The GDC have also conducted an online questionnaire to gather opinions on direct access which elicited 840 responses. To take part in the consultation visit www.gdc-uk.org before 31 December 2012. Consultations are also taking place on CPD for assurance of continuing fitness to practise and on the GDC's standards of conduct, performance and ethics.

Crisis at Christmas are calling for specialist volunteers including dental nurses and dental hygienists to sign up to donate their services to help homeless people in London over the festive season.
