I wonder if you could let me know what staff meetings would have to contain to comply with verifiable CPD regulations. I thought that staff meetings counted as non-verifiable CPD? I would appreciate any advice.

Lesley Derry at the British Dental Association responds: For staff meetings to meet verifiable

CPD requirements, the dental practice would have to set the aims and objectives of the meeting and stipulate the anticipated learning outcomes. At the end of the session, participants would need to give feedback on the subject covered etc and how far the learning objectives were met.

The practice would also need to issue a certificate indicating the subject discussed and the time spent on it. These certificates can be generated in-house.

Therapy training

I have been a tutor on the Hygiene/Therapy course at the DCP School, Bristol Dental Hospital, since October 2005.



The *Vital* article *As dental professionals we should be looking at the whole person* (*Vital* winter 2008 pages 26-27) incorrectly states that we at Bristol run a standalone Hygiene course with an option to continue therapist training in an additional six months. The current situation is thus: we have run a combined 27 month Hygiene/Therapy course since January 2007, but we will, however, in the future be returning to a single diploma in Dental Hygiene.

We have never offered a six month Therapy course, neither will we be doing so; we have, however, run a year's full-time course for qualified hygienists to complete the restorative element that allows them to obtain the Diploma in Dental Therapy.

We will be running a two year part-time course for qualified hygienists who wish to train as dental therapists in the future.

I am not aware of any institution that has considered six months as sufficient time to complete the extensive theory and practical modules that lead to a Diploma in Dental Therapy.
